

Statutory Declaration for Proof of Identity

This information is collected in accordance with the Vital Statistics Act and Regulations. It is required by Vital Statistics to provide a service; and may be used for statistical and genealogical purposes, or delivering joint provincial and federal programs. Collection is authorized under s.33(a) and (c) of the Freedom of Information and Protection of Privacy Act. Important Information

As you the applicant or your designated agent (if applicable) are not in Alberta and not able to appear in person at a registry agent office to provide an original proof of identity document, the identification requirement may be provided in the form of this Statutory Declaration. Proof of Identity must be acceptable.

- The applicant must have the original proof of identity document in their possession (it cannot be a copy, fax, etc.).
- The Proof of Identity document must be issued by a provincial, federal or state government.
- The Proof of Identity document must contain the person's full name.
- The Proof of Identity document must contain the person's photograph.
- The Proof of Identity document must contain a distinct identification number.
- When the Proof of Identity document is one that expires, the document must be valid at the time it is presented to a Commissioner for Oaths or Notary Public.
- When the Proof of Identity document is one that does not expire, the document must have been issued within the last 5 years.

If the Proof of Identity document does not meet all the above criteria, it cannot be used as proof of identity in this Statutory Declaration.

Examples of possible acceptable documents include:

• Drivers licence, provincial identification card, treaty status card, citizenship card, permanent residency card, etc.

Examples of non-acceptable documents include:

• Bank card, Alberta Health Care card, Social Insurance card, charge card, library card, student identification card, etc.

You must sign in front of the Commissioner for Oaths or Notary Public who will authenticate your identity and sign this Statutory Declaration. Take your original Proof of Identity document with you to the Commissioner for Oaths or Notary Public. This Statutory Declaration cannot be faxed or emailed as Vital Statistics requires the original executed Statutory Declaration to process the application.
